COLTENE Holding AG complements its Group Management

Altstaetten, October 29, 2019 – As of January 1, 2020, John Westermeier and Dr. Martin Schlüter will join COLTENE's Group Management. SciCan CEO John Westermeier will be responsible for the sales and marketing organization of the COLTENE Group in North America. Dr. Martin Schlüter, Vice President Research & Development and Innovation, has assumed Group-wide responsibility for research and development. The other members of Group Management remain unchanged.

With the acquisition of SciCan and Micro-Mega, the North American market has become increasingly important for the COLTENE Group. The Board of Directors has therefore decided to establish a separate function for sales and marketing in this region. He is now responsible for R&D at COLTENE worldwide. Dr. Martin Schlüter succeeds Werner Mannschedel, the long-standing Head of Research and Development who will retire at the end of 2019.
